






What is a myth?

Myth

- The connotative meaning that signs carry wherever they go. This idea of myth makes what is cultural seem natural.
- Myths are powerful structural beliefs. They are built out of language and images, which can be studied as signs. Signs are objects with meaning attached to them.









Semiology

- Semiotics was founded by Ferdinand de Saussure by expanded on by Roland Barthes. The goal of semiotics is interpreting both verbal and nonverbal signs
- Ferdinand de Saussure was a Swiss linguist who coined the term semiology
- Ferdinand de Saussure in 1916 wrote a book called general linguists. In this book is where he coined the term sign.









What is a sign?

- A sign-Something that stands in for something else
- Example: Stop sign











A sign has two elements:

- Signifier and Signified definition were made by Ferndinand
- A Signifier- is called the signifier because it creates meaning
- Signified The idea the person is communicating is trying to invoke



Signifier: Red rose with a green stem

 Signifies: a symbol of passion and love - this is what the rose represents



Signifier: Brown cross

 Signifies: a symbol of religion, or to be more specific this is a symbol of Christianity



Signifier: Heart

• Signifies: a symbol of love and affection









Every sign is the result of two interconnected sign systems.

- A. Denotative sign system-A descriptive sign without ideological content. Denotative system which is strictly descriptive.
- B. Connotative sign system- Connotative system which is based on connotation. This means that a neutral sign can become an ideological tool. The original meaning is not lost but it changes.









Roland Barthes

- Roland argues if a sign used a lot it becomes a myth.
- Mythical Signs or Symbol create specific meaning. Signs have a huge amount of influence.
- It is up to the semiologist to expose or deconstruct a mythic sign.
- Deconstruction The process of unmasking contradictions within a text; debunking.










Why is this important?








Black Lives Matter Myth

• The term Lives refers to the women, children, and fathers who have lost their lives. It also refers to men, women, and children who are still living.







- One can choose their occupation, but not just their birth color or race.












Rate of fatal police shooting among Black Americans was much higher than that for any other ethnicity












Black people mostly likely to be killed by police












According to the guardian The FBI released data the showed a decline in police deaths in 2015












Many police officer never face prosecutions for homicides. Even when the killing are captured on video convictions are even












Digital Movement
